**ORDER GRANTING DEBTORS'
FOURTH NON-SUBSTANTIVE OMNIBUS
OBJECTION TO CLAIMS (AMENDED)**

Upon consideration of the fourth omnibus objection to proofs of claim (the "Objection"), of Crescent Resources, LLC and its affiliated debtors in the above referenced chapter 11 cases, as debtors and debtors in possession (collectively, the "Debtors"), which commenced a case under chapter 11 of the Bankruptcy Code on June 10, 2009, pursuant to section 502 of the Bankruptcy Code, Bankruptcy Rule 3007 and Local Rule 3007, requesting that the Court disallow and expunge certain Amended Claims¹; and the Court having jurisdiction to

consider the Objection and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334; and consideration of the Objection and the relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and the Court having reviewed the Objection; the Court hereby finds and determines that, pursuant to Bankruptcy Rule 3007, due and proper notice has been provided to each holder of a claim listed on the attached exhibit and all other parties entitled to notice; and no other or further notice is necessary; and the relief requested in the Objection is in the best interests of the Debtors, their estates, and creditors; and the legal and factual bases set forth in the Objection establish just cause for the relief granted herein; and therefore it is

ORDERED that each Amended Claim listed in Exhibit A attached hereto is hereby disallowed and expunged in its entirety, leaving unaffected each Remaining Claim as listed in Exhibit A; and it is further

ORDERED that GCG is authorized and directed to delete the Amended Claims from the official claims registry; and it is further

ORDERED that the Objection does not constitute an objection to any Remaining Claims; and accordingly, the Objection does not prejudice the rights of the Debtors, or any other party in interest, to object to any such claims on any other grounds whatsoever. Moreover, the Debtors retain all further substantive and/or procedural objections they may have with respect to any Remaining Claims; and it is further

ORDERED that this Court shall reserve jurisdiction to interpret and enforce this Order.
